## Cyber Essentials mark

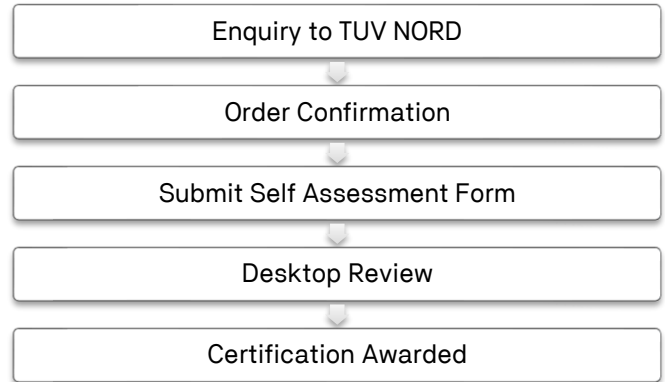

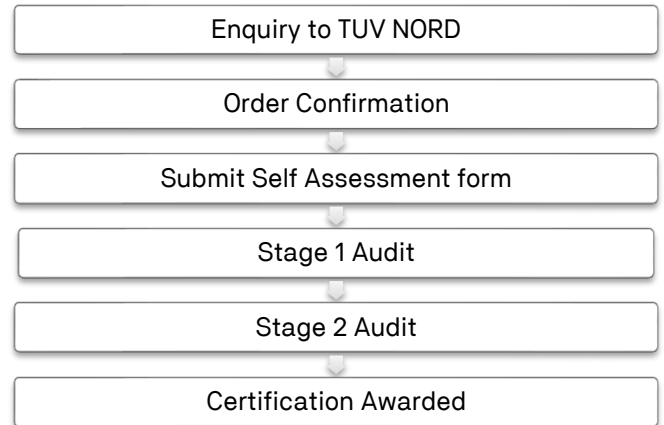
# Cyber Trust Mark

It is aimed at larger or more digitally advanced organizations, considering that these entities are likely to face heightened risk levels, necessitating continual improvement in expertise and resources to safeguard and manage their IT infrastructure and systems. Embracing a risk-based approach, the Cyber Trust mark provides guidance for organizations to comprehend their risk profiles and identify cybersecurity preparedness domains required to mitigate these risks. Functioning as a distinguished indicator, the Cyber Trust mark enables organizations to demonstrate the implementation of robust cybersecurity practices and measures that align with their cybersecurity risk profile.

## Certification Benefits

- The Cyber Trust Mark signifies that organisations are trusted partners with robust cybersecurity practices, enhancing their credibility in the industry.
- Offers a route to international cybersecurity benchmarks (e.g. ISO/IEC 27001)

## Cyber Essentials Mark

- What is the validity of the CSA Cyber Essentials mark?

The CSA Cyber Essentials mark is valid for two years.

- How is the audit conducted for Cyber Essentials mark?

Cyber Essentials mark audit is conducted remotely.

- What is an end-point?  
Anti-malware solutions shall be used and installed in endpoints to detect attacks on the organisation's environment. Examples of endpoints include laptop computers, desktop computers, servers and virtual environments.

- What are the measures of Cyber Essentials Mark?

There are five categories of cybersecurity measures for Cyber Essentials Marks; Asset, Secure/Protect, Update, Backup and Respond.

- Are there any funding support?

## Cyber Trust Mark

- What is the validity of the CSA Cyber Trust mark?

The CSA Cyber Trust mark is valid for three years.

- How is the audit conducted for Cyber Essentials mark?

The CSA Cyber Trust mark audit is conducted both on site and remotely with 2 stage audit.

- Is there surveillance audit?

Yes, there is annual surveillance audit for Cyber Trust Mark during the validity of the certificate.

- Is there any pre-requisite for to obtain Cyber Trust Mark?

There is no pre-requisite to obtain for Cyber Trust Mark.

- Are there any funding support?
